Founded by brothers Rabindra Behera and Suvendra Behera, the company started with a dream to create a lasting impact in the automotive industry. RSB Group is a 3000 crore global engineering powerhouse, with operations spanning India, the USA, and Mexico.

A MODEST START WITH A BIG

The story began in 1973 when the Behera brothers launched International Auto Products in what was then Bihar (now in Jharkhand), with an inistrategic acquisitions and greenfield projects. This diversification reduced risks and strengthened their foothold in the global automotive sector.

GLOBAL FOOTPRINT AND INDUSTRY LEADERSHIP

RSB Group operates 17 manufacturing plants across India, the USA, and Mexico. Headquartered in Pune, the Group comprises:
